#### **DESCRIPTION:**

This position provides primary staffing for the Adult Health, Family Planning and Maternal Health Programs; serves as the lead RN for the EIC (Early Intervention Clinic). Additionally, this nurse will be assigned to the General Services and Sexually Transmitted Disease (STD) Programs as needed. Position also performs any duties assigned by clinical coordinators, supervisor, director of nursing and health director.

#### **EXAMPLES OF DUTIES:**

1. Screens patients in Adult Health/Family Planning/Maternal Health and EIC Programs for physical assessment by the Physician Assistant/Physician Extender.
2. Documents medical history, allergies, medications, immunizations, chief complaint, chronic illnesses, history or present illness and review of systems.
3. Measures weight, height, temperature, pulse, respiration, body mass index (BMI) and blood pressure.
4. Performs vision and hearing tests as indicated for school/work physical examinations.
5. Updates immunizations and gives PPD skin test as indicated for school or work physical examination.
6. Assists the Physician Assistant/Physician Extender as needed in the care of the Adult Health patient. Provides counseling and education on the following but not limited topics:
  - Healthy pregnancy
  - Anatomy and Physiology of Pregnancy
  - Pre-term Labor signs and relief measures
  - Serum Quad Screening
  - Laboratory test results
  - Pap Test Screening- normal and abnormal
  - Vaginal infections- yeast, bacterial
  - Sexually Transmitted Diseases- Chlamydia, Gonorrhea, Genital Warts (HPV), Herpes, Hepatitis, Syphilis, HIV
  - Group B Beta Strep Infections
  - Contraceptive Methods
  - Immunizations

#### **TYPICAL QUALIFICATIONS:**

Graduation from a 4 year college or university with a B. S. Degree in Nursing, which includes a public health nursing rotation; or graduation from an accredited school of professional nursing and one year of professional nursing experience; or an equivalent combination of education and experience. Minimum Education and Experience for a Trainee Appointment - Graduation from an accredited school of professional nursing.
